Confirmed were Commissioners John Browning, Jr. of Palatka, David Genson of Naples, and Jay Trumbull, Sr. of Panama City.

# John Browning, Jr.

Browning is the VP of New Projects for The Goodman Company, headquartered in West Palm Beach, Florida; founded in 1960 in Allentown, Pennsylvania.
